TEMPORARY MEMBER SLIPS CONTRACT

This contract is for Temporary Members. Once signed, it is confirmation that the applicant has agreed to the fees and the terms and conditions as laid out below.

THE FEES

Slip Up: \$200

Slip down: \$200

Daily rate: \$75 per day (midnight to midnight)

Fob keys: Deposit of \$100 each, rebated upon return undamaged

High Pressure Hose: \$50 per day

TERMS & CONDITIONS

Temporary membership begins at haul-out and ends with the return to the water. It includes fob key access to the slips and to clubroom facilities, including the bar.

Staying aboard a boat or anywhere on club premises overnight is prohibited. Temporary Members are subject to the same rules as all other members; see our website for more information.

The invoice will be issued at the conclusion of the slips work. This must be settled in full before the boat is returned to the water. Any unreasonable delay in payment, or in return to the water, may bring additional daily fees.

VESSEL SLIPPING INDEMNITY FORM

I understand it is my responsibility to prepare and move my vessel onto an appropriate cradle, set the arms and secure it. When the winch process begins the Slip Master/winch operator has control of the operation. At the completion of the slipping operation, when the vessel begins to float from the cradle, the responsibility returns to the boat owner/operator.

This indemnity is subject to the slipping being conducted in a manner consistent with the Standard Operating Procedures and relevant club bylaws.
